III. Guest Speaker

Kristin Moser, Director of Institutional Research & Effectiveness, spoke about the results of the Chronicle of Higher Education's "Great Colleges to Work For" survey from April 2018. The survey was also conducted in 2014 and 2015, and they are hopeful that this survey will become a regular event. The survey has shown across the years that there has been significant increases in multiple categories, demonstrating improved employee job satisfaction.

IV. <u>EMT Report</u> – Michael Hager

On-campus interviews for the Vice President of University Advancement position will be conducted most likely in mid-May. There will be an announcement as the date gets closer. Legislature approval of the majority of the FY20 Board of Regents funding request is expected; the Board will determine how this budget will be distributed among the regents institutions. UNI hopes to receive the full \$4 million the University has requested. The Board will also be looking at tuition rates for UNI, specifically tuition for out of state students.

V. <u>HRS Report</u> – Michelle Byers

The last Biometric Screening of the semester will be on April 26th. Please register online if you'd like to participate. HRS will soon be sending out salary increase letters. The EAP program has launched a new feature which is an online chat option. This is only an initial outreach tool, such as for scheduling an appointment, and will not replace an inperson session. UNI has elected to provide the additional 10% incentive for those entering into a two year phased retirement agreement through June 30, 2022. For more information, visit the HRS benefits webpage. The lower student enrollment for fall 2019 will result in a budget shortfall in many divisions. Should there be a need for position cutbacks, it would be on a department-by-department basis. However, many vacant positions are being held for the time being.
